Code: The program staff is required to protect the children from hazardous conditions in the outdoor play area.

Findings: "During the inspection, it was determined that the following hazardous conditions existed in the outdoor play area, as noted in number(s) 9 below:

1. There was broken glass.
2. There were tall weeds.
3. There was poison ivy.
4. There were protruding bolts.
5. There were tree branches.
6. There was mold visible.
7. There were thistles with pricklers.
8. There were bird droppings.
9. Other There was a loose board on the fence and nails were sticking out.
