Finding: During the inspection, it was determined that a child had been placed in a crib with an object that created a potential strangulation or suffocation risk, as indicated in number(s) 1 below:

1. Item tied around neck (including bib or pacifier on ribbon or string around child's neck)

9. Stuffed animal that is large/soft enough to conform to the shape of the child's face
