Code: The program staff is required to follow diaper changing procedures.

Finding: During this inspection, it was determined that proper diaper changing procedures were not followed as the staff person in the toddler room opened a common container (diaper pail) using hand instead of pedal to dispose of the soiled diaper and separation material pad and the diaper pail became contaminated. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is not required at this time.
