Code: The program staff shall use developmentally appropriate techniques when managing children's behavior. Corporal punishment is prohibited, as well as any cruel, harsh, unusual or extreme techniques.

Allegation: Child care program uses inappropriate guidance and management techniques, staff speak to children in a loud voice that is not appropriate.

Determination: Substantiated

Findings: During the inspection, it was determined that a child care staff member used a discipline technique to guide or discipline child(ren) that was not developmentally appropriate, consistent, or occurred at the time of the incident. Infants must be provided with a crib, which meets requirements specified in this rule, for resting and sleeping. Provide staff training.
