Child care programs will not be cited for failure to complete the Center Staff Orientation for any individual hired on or after April 1, 2022 as long as these individuals complete the training by July 31, 2022. <p>Child care staff members who have taken the Center Pre-Licensing Training in place of the Center Staff Orientation do not need to take the Center Staff Orientation. CCSM 's with training documented on the old JFS 1246 (3-2007) are to complete the online training prior to the next inspection.</p>
