Rule: 5101:2-12-19 Supervision

Code: The program is required to obtain written parental permission for a school-age child who may walk to or from the program from another destination.

Finding: During the inspection, it was determined that written permission had not been secured, as required by this rule, from the parent/guardian for school children for number 3 below:

3. Participation in activities inside the building that are sponsored by another group.

Code: The program is required to conduct and document quarterly inspections of their outdoor play space.

Finding: During the inspection, it was determined that quarterly inspections of one or more outdoor play area(s) and equipment had not been completed and documented as required, using the JFS 01281 "Child Care Playground Inspection Report" form. Finding: During the inspection, it was determined that the dome climber and green/gray slide were positioned such that the fall zone requirement in number(s) 4, 6 below was not met:

1. The fall zone was less than 3 feet from the fence for equipment used by children 23 months of age and younger.
2. The fall zone was less than 6 feet from the fence for equipment used by children 24 months of age and older.
3. There was not a fall zone of 3 feet in all directions from the perimeter of the equipment used by children 23 months of age and younger.
4. There was not a fall zone of 6 feet in all directions from the perimeter of the equipment used by children 24 months of age and older.
5. The fall zone was less than 4 1/2 feet from each piece of applicable equipment used by children 23 months of age and younger.
6. The fall zone was less than 9 feet from each piece of applicable equipment used by children 24 months of age and older.
7. Other.

10. Name and/or signature of the person completing the form;
