<u>Finding</u>: During the inspection, it was determined that at least one piece of equipment, furnishings, or material at the program was not constructed of materials to facilitate cleaning and sanitizing as noted in number 1 below:

- 1. The material had a tear on the blue couch in the toddler room.
- 2. The material was not washable
- 3. The material was porous;
- 4. The surface was cracked;
- 5. The surface was repaired, but in a manner that still did not facilitate cleaning and sanitizing;

During the inspection, it was determined that at least one area of the program or at least one piece of equipment had chipping or peeling paint. or is in the process of being immunized against the diseases required by division 5104.014 of the Revised Code
and found in appendix A to this rule
9. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have
the child immunized against the disease for reasons of
conscience, including religious convictions
