Findings: During the inspection, it was determined that a child care staff member in the toddler room used a discipline technique to guide or discipline child(ren) that was not developmentally appropriate, consistent, or occurred at the time of the incident in that, the tone of voice used with toddlers is stern. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
