Rule: 5101:2-12-12 Safe Environment

Code: The program is required to store chemicals in a place that is inaccessible to children.

Finding: During the inspection, it was determined that the toddler and young preschool group was served gel fruit snacks and whole grapes, which posed a choking hazard/was not appropriate for their age. Rule: 5101:2-12-10 Health Training Requirements

Code: The program is required to have staff complete training in child abuse and neglect recognition and prevention within sixty days of hire.
