Findings: During the inspection, it was determined 7 children with 3 under two years of age were in the care of one child care staff member which resulted in more than six children. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

9. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
