Finding: During the inspection, it was determined the JFS 01242 "Medical, Dental and General Emergency Plan for Child Care" was not posted as required by rule. Both sides of the 1242 need to be visible. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program staff is required to protect the children from hazardous conditions in the outdoor play area.

Finding: The following hazardous conditions existed in the outdoor play area, as noted in number 1 below:

1. There was a broken window in the play house.
2. There were tall weeds.
3. There was poison ivy.
4. There were protruding bolts.
5. There were tree branches.
6. There was mold visible.
7. The sandbox was contaminated.
8. There were thistles with pricklers.
