Rule: 5101:2-13-04 Fire Inspection for Type A Homes

Code: The program is required to have a fire approval completed within 12 months from the date of the last fire approval.



Findings: The program had not been inspected and approved within 12 months from the date of the last fire approval by the local fire department, as required. Findings: During the inspection, it was determined the water temperature was 128 degrees in the kitchen. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

3. Quarterly emergency/lockdown drills.

Correct the violation and submit proof of insurance with the program's corrective action plan to verify compliance with the requirement of the rule.

Findings: In review of the children's records, it was determined that completed medical statements were not on file, as required, for children listed on the JFS Children's Record Review For Child Care as indicated in numbers 1 and 2 below:

2. Medical(s) on file was not updated every 13 months
3. Medical(s) were missing child's name and date of birth

9. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
