Finding: During the inspection, it was determined that the method for tracking children in each group did not meet the requirements of the rule as noted in number(s) 5 below:

1. There was no method in place;
2. The method did not include each child's name;
3. The method did not include each child's date of birth;
4. The tracking method did not remain with the group at all times;
5. The tracking method was not updated throughout the day as children entered or left the group.

Finding: During the inspection, it was determined that the sandbox did not meet the requirements of the rule as the sandbox was not covered when not in use. The sandbox must be covered. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is not required at this time.

Finding: During the inspection, it was determined that the program's weekly menu was not currently dated as required.
