<u>Code</u>: The program is required to use the appropriate form and retain current documentation to administer medications. - 18. Staff member's signature was missing on the JFS 01217.
- 19. A prescription label was not attached to the prescription medication.

- 20. Name of any applicable medication was missing.
- 21. Date medication was administered was missing.
- 22. Time medication was administered was missing.
- 23. Dosage administered was missing.
- 24. Signature of staff member who administered the medication was missing.
- 25. Medication listed in the procedures to follow was not onsite available to administer as instructed and alternate instructions for this situation were not included on the plan.
- 26. The plan was not implemented.
- 27. The plan was not able to be implemented due to conflicting information.
- 28. The plan was not followed.
