#### Domain: 04 Indoor/Outdoor Space

Rule: 5101:2-12-11 Outdoor Space Requirements

Code: The program is required to have an outdoor play space free from immediate risk.

Finding: During the inspection, it was determined that an area was used which was not protected from traffic and other hazards by a fence in good condition, or other barrier, that assured children were not able to leave the playground area. The fence or natural barrier was determined to present an immediate risk for a child to be able to leave the playground as noted in number(s) 8 below:

1. The fencing had missing slat boards through which children could leave the playground.
  2. The gate was broken and did not close.
  3. The latch on the gate was broken.
  4. The gate had no latch.
  5. The fencing was broken.
  6. The latch was easily opened by children on the playground.
  7. The portable fencing approved for use by the Department was not being used.
  8. Other: The natural barrier used was not continuous and had gaps in which a child could leave the space and the play area was near a parking lot.
- Discontinue use of the playground and provide a space for outdoor play which is well defined by a fence or other barrier and protected from other hazards.



Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.
