Finding: During the inspection, it was determined the administrator, child care staff, and/or employees of the program did not protect a child in that a child was left on the playground alone for approximately three minutes when transitioning from the playground to indoors.

All program employees must take actions to protect children in care. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
