The ratio determined for the mixed group of toddlers -school agers was 1 Child Care Staff Member for 21 children. Additionally, a ratio of 1 Child Care Staff Member for 20 children was determined for the preschoolers - school agers group.

Additional staff members must be hired or current Child Care Staff Members must be rescheduled to maintain compliance. Provide staff training.
