<u>Finding</u>: During the inspection, it was determined that Child Care Staff Member had sole responsibility of children in the group 3's and the JFS 01176 "Program Notification of Background Check Review for Child Care" was not on file as required. 9. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of

conscience, including religious convictions
