- 6. There were thistles with prickers.
- 7. There were bird droppings.
- 8. There were bolts with more than two threads exposed along a fence line or gate on a playground.
- 9. The sandbox was contaminated.

10. Other, the original play space which was approved, was not being used, due to repairs needed in the ground surface.
