Rule: 5101:2-12-18 Attendance Records

Finding: During the inspection, it was determined the program did not meet the requirements for keeping an attendance record as listed in number 2 below:

1. No attendance record was being maintained;
2. The attendance record was not being consistently completed, in that it had not been completed in the Infant 1 room;
3. The attendance documentation was not kept at the program for a period of one year.

Rule: 5101:2-12-23 Infant Bottle and Food Preparation

Rule: 5101:2-12-20 Cribs

Finding: During the inspection, it was determined that at least one crib was not labeled with the child's name, as required by this rule.
