<u>Code</u>: The program is required to place infants in cribs while sleeping.

<u>Finding</u>: During the inspection, it was determined that the equipment in number(s) 6 below had been used for sleeping infants and did not allow the infant to sleep on a firm mattress:

1. Mesh cribs;

2. Play pens;

- 3. Bassinets;
- 4. Cots;



5. Car seats;

6. Infant swing; 3 were asleep in swings upon arrival and 2 were placed in crib leaving 1 still sleeping in swing.

- 7. The floor;
- 8. Infant seats;

9. An infant placed in a car seat in a crib;
