Rule: 5101:2-12-04 Building Department Inspection

<u>Code</u>: The program is required to refrain from using space that did not receive building approval and from caring for children in spaces not approved for that age group. <u>Finding</u>: During the inspection, it was determined the program was wanting to use space for child care in a manner that was not approved by the Ohio Department of Commerce or local certified building authority as noted in number(s) [] below:

- 1. The rooms or spaces were not approved by the building department as the certificate of occupancy was not submitted.
- 2. Children under school age were being cared for in a building only approved for school age.
- 3. The space had been modified and not yet re-inspected and approved.
- 4. The [] floor, which had not been approved by the building department for child care, was being used.

- 5. The building limitation had been exceeded. [] children were being cared for and the building had been approved for [] children.
