Findings: During the inspection, it was determined that the following unsanitary conditions were at the program: Dirty tile floors, dirty carpet, fly strips with a large amount of dead flies, dirty windows, dirty trash cans, unclean equipment, bathroom concerns noted in unclean restroom non-compliance. A clean and healthy environment, including furniture, materials and equipment must be provided, and the program shall be cleaned daily. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is not required at this time.

Findings: During the inspection, it was determined that unsanitary conditions, as noted in number(s) 4, 8, 9 below, were in the preschool restroom:

1. There was no liquid soap.
2. There was no toilet paper.
3. There were no paper towels.
4. The toilet cleaning brush was accessible to the children.
5. The plunger was accessible to the children.
6. The toilet(s) were not flushed.
7. The trash was not emptied from the day before.
8. There was a strong urine odor.
9. Other soiled pull-up on the floor.

The restroom(s) must be kept sanitary at all times. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is not required at this time.
