Finding: During the inspection, it was determined that the following equipment manufactured with straps; infant feeding table was not being used appropriately as noted in the following number(s) 2 below:

Finding: During the inspection, it was determined that a fall zone hazard was present, in that, the plastic movable equipment on the toddler playground was positioned too closely together and posed a risk of injury if a child were to fall from a piece of equipment.
