During SUTQ visit, infants were observed being swaddled in blankets not meant for swaddling

2. Pacifier clip/ribbon
3. Teething jewelry
4. Blanket for infant under twelve months old
5. Pillow

9. Diaper bag
10. Object or toy strung over the crib in which a child can pull himself up

Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
