Rule: 5101:2-12-12 Safe Environment

During the inspection, it was determined that at least one area of the program or at least one piece of equipment had chipping or peeling paint (3/4's restroom wall near toilets and outside of door to playground off 3's room). Rule: 5101:2-12-11 Outdoor Space Requirements

Code: The program is required to have an outdoor play space free from general hazards.

Finding: During the inspection, it was determined that the following hazardous conditions existed in the outdoor play area, as noted in number(s) 10 below:

1. There was broken glass.
2. There were tall weeds.
3. There was poison ivy.
4. There were tree branches.
5. There was mold visible.
6. There were thistles with pricklers.
7. There were bird droppings.
8. There were bolts with more than two threads exposed along a fence line or gate on a playground.
9. The sandbox was contaminated.
10. The black mesh weed barrier was protruding through the mulch in several areas on the large playground causing a tripping hazard.
