Allegation: The complainant alleged that a child was scratched when a teacher grabbed them by the arm.

Determination: Substantiated

Findings: During the inspection, it was determined that a child care staff member used a discipline technique to guide or discipline child(ren) that was not developmentally appropriate, consistent, or occurred at the time of the incident (Not developmentally appropriate-grabbed a child by the arm resulting in scratches on the child) . Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
