1. There was rust exposed; (Pole attached to large climbing structure and tricycle on 4's playground)
2. There was protruding bolts;
3. There were cracks;
4. There were holes;
5. There was splintering wood;
6. There were sharp edges or points; (Broken flag pole mount on 4's playground structure)
7. There were lead hazards;
8. There were toxic substances;
9. There were tripping hazards;
10. There was chipped and/or peeling paint;
