Code: The program is required to provide enough space between equipment to not pose a risk of injury.



Finding: During the inspection, it was determined that the outdoor play equipment was positioned too closely together, posing a risk of injury if a child were to fall from one piece of equipment into another (teeter totter in front of swings, bench along fence and dome climber) Submit the program’s corrective action plan to the Department to verify compliance with the requirements of this rule.

Rule: 5101:2-12-25 Medication Administration and Food Supplements

Code: The program is required to use the appropriate form and retain current documentation to administer medications.
