Code: The program staff is required to supervise children on the vehicle at all times during a trip.

Finding: During the inspection, it was determined that children were left unattended on a vehicle used by the program for a routine trip, when the staff member did not see a child sleeping on the vehicle when they performed the procedures for exiting the vehicle. The staff member went into the building and then realized the child was still on the vehicle. Children must be supervised at all times and an adult must be present with the vehicle anytime children are in the vehicle. Provide staff training. Submit the program's corrective action plan, which includes a statement ensuring children are supervised at all times, and a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
