Finding: During the inspection, it was determined that a medication, cough drops and Emergen C, was within the reach of children in the drawer in the preschool rooms. All medications must be stored out of the reach of children. Create procedures that assure medications will always be inaccessible to children. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

The potentially hazardous substance was determined to be accessible to children in the following area: girls restroom cupboard.
