**Domain: 04 Indoor/Outdoor Space** 

Rule: 5101:2-12-11 Outdoor Play Equipment

<u>Code</u>: The program is required to provide equipment that does not pose a safety risk.

<u>Finding</u>: During the inspection, it was observed that the toddler climber posed a safety risk, in that the railings on each side of the walkway to the slide are coming out at the bottom and need to be snapped back in to place. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

Rule: 5101:2-12-10 Health Training Requirements
