Findings: During the inspection, a potentially hazardous item or toxic substance was used or stored where children had access to it as noted in number(s) 2,9 below. The potentially hazardous substance or item that posed a risk to children was determined to be accessible to children in the child care restroom area in the cabinet above the sink (Aerosol hairspray) and the child care kitchen area in the cabinet under the kitchen sink (cleaning agent).
