Code: The program is required to supervise children.

Findings: During the inspection, it was determined that children were left unattended and not supervised, in that child got belt around neck within sight or hearing. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

 13. Procedures for communicating with parents during loss of communications, no phone or internet service available
 14. The location of supplies and procedures for gathering necessary supplies for staff and children if required to shelter in place
 15. What to do if a disaster occurs during the transport of children or when on a field trip or routine trip
 16. Training of staff or reassignment of staff duties as appropriate
 17. Updating the plan on a yearly basis
 18. Contact with local emergency management officials

4. Departure and return time of the trip (field trips only);

6. Date on which the permission was signed;

Rule: 5101:2-13-14 Requirements for Field and Routine Trips

Code: The program is required to have written parental permission for trips on file.

Findings: During the inspection, it was determined that written parental permission was not secured for field trips and/or routine trips off the premises or out of the areas approved for child care, as required. 4. At least one individual's schedule was not current.
5. At least one individual's position or role was not current.
6. At least one individual's employment or residence had not been end dated.
