3. Electrical/Extension cords attached to an object that would likely result in a severe injury if pulled;

6. Diaper bags;
7. Television not securely anchored;
8. Small or lightweight pieces of shelving units are not securely anchored to the wall;
9. Staff member stepped over a barrier/gate while holding a child;
10. Chipping or peeling paint;

In the childcare living room area the window blinds have pull cords hanging down that are accessible to the children in care. Children in care shall be protected from any items and conditions which threaten their health, safety, and well being.
