5. The time (hours and minutes) of each child's arrival and departure to the program, including transportation by the program was missing, provider had two children checked in when there were 4 present.

10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
