Findings: During the inspection, it was determined that the program did not have a well-balanced daily schedule that covered all hours of operation as noted in numbers 1,2,3 below

- 1. The classroom(s) did not did provide opportunities for a balance of quiet and active play.
- 2. The classroom(s) did not provide activities to promote the children's physical, social-emotional, cognitive and language development.
- 3. The classroom(s) did not provide opportunities for child initiated activities.

A well-balanced program of activities for all hours of operation suitable to the developmental levels and abilities of each child in care shall be implemented on a daily basis.
