Rule: 5101:2-13-12 Safe Environment

Code: The program is required to refrain from using and storing outdoor machinery around children.

Findings: During the inspections, a potentially hazardous substance, which was determined to not present a serious risk to a child, was accessible to children as noted in number 11 below:

11. Other potentially hazardous substance, in the kitchen under the sink the latch was broke and there were several cleaning supplies such as spray disinfectants, Febreze spray, Off Bug spray, dish soap etc. and also another cabinet in the kitchen with a broken latch with vinegar inside.

The potentially hazardous substance was determined to be accessible to children in the following area, the kitchen.

Rule: 5101:2-13-12 Safe Environment

Code: The program is required to protect children in care from items and conditions that threaten their health, safety, and well being.

Findings: Children in care shall be protected from any items and conditions which threaten their health, safety, and well being. During the inspection, it was determined that children were not protected from the following item(s) or condition(s) which may threaten their health, safety, or well being as noted in the following number 9 below:

- 1. Telephone cords;
- 2. Stacked chairs;
- 3. Employee(s) purse(s);
- 4. Diaper bags;
- 5. Television not securely anchored;
- 6. Small or lightweight pieces of shelving units are not securely anchored to the wall;
- 7. Staff member stepped over a barrier/gate while holding a child;
- 8. Chipping or peeling paint;
- 9. In the kitchen there was a drawer with two hammers inside within children's reach.

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Domain: 04 Indoor/Outdoor Space

Rule: 5101:2-13-11 Outdoor Equipment Code: Outdoor equipment is required to be safe.

Findings: During the inspection, it was determined that outdoor play equipment was unsafe as noted in the number 9 below:

- 1. There was rust exposed.
- 2. There were protruding bolts.
- 3. There were cracks.
- 4. There were holes.
- 5. There was splintering wood.
- 6. There were sharp edges or points.
- 7. There were toxic substances.
- 8. There were tripping hazards.

9. On the outdoor play climber there was a ladder that was not secured and leaning against the playset, there was a plastic type enclosure that was missing a screw and a child could possibly become entrapped in the opening. There was a toy bulldozer push toy that was broken and had sharp edges.

Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.
