Findings: During the inspection, it was determined that while observing the outside play area a hazardous area was observed. Under the back porch there was access to a mower, 2 gas cans and a pressure washer was located on the back porch. these items were being stored in the outdoor area where children had access. The provider must have a plan to ensure that children will not be outside near machinery which is in operation or being stored. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Code: The program is required to protect children in care from items and conditions that threaten their health, safety, and well being.

Findings: Children in care shall be protected from any items and conditions which threaten their health, safety, and well being. During the inspection, it was determined that children were not protected from the following item(s) or condition(s) which may threaten their health, safety, or well being as noted in the following number 12 below:

1. Open pull cords that are not closed loop;
2. Telephone cords;
3. Electrical/Extension cords attached to an object that would likely result in a severe injury if pulled;
4. Stacked chairs;
5. Employee(s) purse(s);
6. Diaper bags;
7. Television not securely anchored;
8. Small or lightweight pieces of shelving units are not securely anchored to the wall;
9. Staff member stepped over a barrier/gate while holding a child;
10. Chipping or peeling paint;
11. Emergency exits were blocked by the following furniture: [];
12. Other (Water temperature in upstairs bathroom where children was their hands is supposed to read 120 degrees maximum. During inspection it was observed that the water temperature read 127 degrees).
