Domain: 02 Safe & Sanitary Environment

Rule: 5101:2-13-12 Safe Environment

Code: The program staff is required to remove, replace, or repair any equipment that may be hazardous to children.

Findings: During the inspection, the following item(s) were observed to be hazardous to children in that when entering the FCC Providers home, hazardous conditions were observed. The handle going up the stairs on the outside porch is broken, there was ice on all of the steps and 3 pieces of sharp downspout were laying on the front porch. While inspecting in the home it was observed that a heating pad plugged into an extension chord on the couch was in reach of the children in care which poses a choking hazard. The equipment or hazardous condition must be removed, replaced, or repaired. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Rule: 5101:2-13-15 Health Conditions

Code: The program is required to follow the procedures outlined on the JFS 01236 "Medical/Physical Care Plan".

Findings: During the inspection, it was determined the JFS 01236 "Medical/Physical Care Plan" was not implemented. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Low Risk Non-Compliances

Domain: 07 Diapering & Infant Care

Rule: 5101:2-13-23 Diapering

Code: The program staff is required to wash all soiled areas with a sanitary wash cloth or a disposable wipe.

Findings: During the inspection, it was determined that the program did not wash all soiled areas of the child's body with a wash cloth which was then appropriately sanitized, or a disposable wipe. Submit the program's corrective action plan to verify compliance with the requirements of this rule. During inspection it was observed while FCC Provider was changing the child's diaper that gloves were not removed that were used to change the child's diaper with before FCC Provider wiped the child's nose.

Rule: 5101:2-13-08 Substitute Requirements

Code: The program is required to have substitutes that meet the requirements in rule.

Findings: During the inspection, it was determined that a substitute did not meet the following requirements. When checking the training documentation in OCCRA the training was not linked to the FCC Provider's business as a Substitute. This was also checked directly in OCCRA. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule. TCJFS left the phone number for OCCRA 877-547-6978 with the FCC Provider to fix this immediately.
