3. Complete physician information;
4. Information regarding the parent list;
5. Health information;
6. Additional information for all boxes checked "yes";
7. Emergency transportation information;
8. Parent/guardian's signature;



- 9. Diapering statement;
- 10. Acknowledgement of policies and procedures;
- 11. Provider's signature.

Correct the violation and submit the program's corrective action plan to verify compliance with the requirements of this rule.
