Code: The program is required to monitor the number of children in care to remain within the licensed capacity.

Findings: During the inspection, it was determined there were eight children in care during the hours of operation, which is over the capacity listed on the license. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Code: The program is required to follow group size requirements.

Findings: During the inspection, it was determined eight children with two under two years of age were in the care of one child care staff member which resulted in more than six children/three children under two years of age. 7. Emergency transportation information;
8. Parent/guardian's signature;
9. Diapering statement;
10. Acknowledgement of policies and procedures;
11. Provider's signature.
