Code: The program is required to refrain from using and storing potentially hazardous items, toxic substances, and outdoor machinery around children.

Findings: During the inspection, a potentially hazardous item or toxic substance was used or stored where children present had access to it as noted in number 14 below. 17. Other, Large free standing upright couch on front porch, wicker furniture stacked on the front porch, large flat screen tv in playroom not anchored with cords on the floor.

Any hazardous equipment must be removed, replaced, or repaired and any hazardous condition must be corrected and must be made inaccessible to children. Provide staff training. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
