Findings: During the inspection, it was determined a pool was located on the premises and was accessible to children in care as there was no fence or physical barrier as outlined in rule in that a minimum of four feet walls that are non-climbable and non-inflatable and the means of access to the pool is secured, locked or removed to



prevent access to pool water. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
