Findings: During the inspection, it was determined medication (Pepto Bismol) was in the reach of children. Correct the violation and submit the program's corrective action plan within 30 days to verify compliance with the requirement of the rule.

Low Risk Non-Compliances

Domain: 04 Indoor/Outdoor Space

Rule: 5101:2-13-11 Outdoor Equipment



Code: The program is required to place equipment away from main traffic patterns that would create unsafe conditions.

Findings: During this inspection, it was observed that the following equipment, plastic basketball hoop located under monkey bar was placed in the main traffic pattern, which created an unsafe condition. Correct the violation and submit the program's corrective action plan within 30 days to verify compliance with the requirement of the rule.

Code: Outdoor equipment is required to be safe.

Findings: During the inspection, it was determined that outdoor play equipment was unsafe as noted in the numbers 3 below:

1. There was rust exposed.
2. There were protruding bolts.
3. There were cracks.
4. There were holes.
5. There was splintering wood.
6. There were sharp edges or points.
7. There were toxic substances.
8. There were tripping hazards.

Plastic chain coverings were observed to be cracked.

9. Medical(s) were missing a statement from the physician, PA, APN, or CNP that the child has been immunized or is in the process of being immunized against the diseases required by division 5104.014 of the Revised Code and found in appendix A to this rule
10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
