Code: The program is required to store toxic chemicals out of the reach of children.

Findings: During the inspection, it was determined the following cleaning or sanitizing equipment yard chemicals was located in the following area back yard and was accessible to children. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to provide a safe environment that may include items such as fans, pipes, space heaters, and air conditioning units.



Findings: During the inspection, it was determined that the program's equipment was unsafe as noted in the following numbers 6 below:

1. A fan was unstable and could easily tip over;
2. A fan had openings a finger could enter;
3. Pipes from the heat pump felt hot to the touch;
4. The space heater felt hot to the touch;
5. The position of the space heater was a tripping hazard;
6. The air-conditioning unit was not enclosed and was accessible to children on the playground;

Findings: During the inspection, it was determined that surge protectors or outlets did not have childproof receptacle covers. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to complete and document weekly vehicle inspections.

Findings: During the inspection, it was determined that the program and/or transportation services had not documented weekly inspections of vehicles used for transporting children. The weekly inspection needs to include the following: 1-6

1. A visual inspection of the tires for wear and tire pressure;
2. A visual inspection of headlights, taillights, signals, mirrors, wiper blades, and dash gauges;
3. An inspection for properly functioning child and driver restraints;
4. An inspection for properly functioning doors and windows;
5. An inspection for, and cleaning of, debris from the inside of the vehicle;
