Code: The program is required to have running water below the temperature of 120 degrees Fahrenheit.

Findings: During the inspection, it was determined the water temperature was 135 degrees Fahrenheit in the following room, kitchen. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit.

Code: The program is required to store alcohol so it is not accessible by children.

Findings: During the inspection, alcohol was determined to be in a space that was visible to children, but not accessible. Submit the program's corrective action plan to verify compliance with this rule.

Code: The program is required to protect children in care from items and conditions that threaten their health, safety, and well being.

Findings: Children in care shall be protected from any conditions which threaten their health, safety, and well being. During the inspection, it was determined that children were not protected from the following conditions which may threaten their health, safety, or well being as noted in the following number 12 below:

1. Open pull cords that are not closed loop;
2. Telephone cords;
3. Electrical/Extension cords attached to an object that would likely result in a severe injury if pulled;
4. Stacked chairs;
5. Employee(s) purse(s);
6. Diaper bags;
7. Television not securely anchored;
8. Small or lightweight pieces of shelving units are not securely anchored to the wall;
9. Staff member stepped over a barrier/gate while holding a child;
10. Chipping or peeling paint;
11. Emergency exits were blocked by the following furniture: [ ];
12. Other - Kitchen drawer needs a lock

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

1. The JFS 01176 "Program Notification of Background Check Review for Child Care" the program received from the Department was not on file and the individual was not left alone with children.
2. The JFS 01177 "Individual Notification of Background Check Review for Child Care" was on file instead of the JFS 01176.
3. The JFS 01176 on file was for a different program.
4. The JFS 01176 "Program Notification of Background check Review for Child Care" was not on file at the program, but was on file at the county agency and the individual is eligible.
