8. Stove(s) that are either on or able to be turned on by a child.
9. Asbestos.
10. Traffic. no pathway to outside emergency escape route

14. A crockpot used to heat bottles.
15. Immediate access to a knife.
16. Large or heavy pieces of shelving units are not securely anchored to the wall.
