Code: The program is required to refrain from using and storing outdoor machinery around children.

Findings: During the inspection, a potentially hazardous item or toxic substance was used or stored where children had access to it as noted in number- 2 below. The potentially hazardous substance or item that posed a risk to children was determined to be accessible to children in child care bathroom under the sink in unlock cabinet.

1. Bleach.
2. Cleaning agent.
