Missing JFS 01236 for child with specialized lactose formula. Missing JFS 01236 for child reported by provider to have special cognitive needs.

Submit the program's corrective action plan, which includes a copy of the completed JFS 01236 "Child Medical/Physical Care Plan", to the Department to verify compliance with the requirements of this rule.

Code: The program is required to store medication out of the reach of children.

Findings: During the inspection, it was determined medication was in the reach of children. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule. Insulin medication observed inside the kitchen fridge door.

Findings: During the inspection, it was determined that a pet at the program posed a threat to the safety or health of the children, in that [proper licensing and/or inoculations not on file/ children exposed to pet's urine and/or feces/ other safety concerns in that [feces observed inside area of play clubhouse that is located in the back yard]. Findings: During the inspection, it was observed that the form used to document infant routines and activities, as required by this rule, was incomplete in that the required information regarding [1, 3] was missing from the form:

- 1. Food intake;
- 2. Sleeping patterns;
- 3. Times and results of diaper changes;
- 4. Information about daily activities.

Code: The program is required to provide a mattress that meets the size requirements for all cribs and playpens.
